

# Penn Township Municipal Authority Sewer Rules & Regulation Revisions

### Adopted November 5, 2015:

Effective January 1, 2016, all Non-Domestic Establishments connected to the Penn Township Municipal Authority's Sewer System <u>and</u> a public water system shall pay sewer rates on the basis of their water consumption at 125 gallons per equivalent dwelling unit (EDU), payable at the rate of \$85.00 per EDU (or at the current sewer billing rate as established by the Authority) with EDU's being rounded off to the nearest whole EDU and a minimum of 1 EDU per quarter. All Non-Domestic Establishments <u>not</u> connected to a public water system, are permitted to pay sewer rates using the aforementioned method by voluntarily purchasing a water meter through the Authority and connecting it to their private water system, with all expenses being the responsibility of the Non-Domestic Establishment.

### Adopted November 5, 2015:

Effective January 1, 2016, all PTMA sewer rates will <u>decrease</u> from \$95.00 per Equivalent Dwelling Unit (EDU) per quarter to \$85.00 per EDU per quarter or \$340.00 per annum per EDU.

### Adopted December 3, 2015:

Effective January 1, 2016, Article II – Sewer Rates and Other Charges, Section 2.01B – Non-Domestic Establishments of the PTMA Sanitary Sewer Schedule of Rates and Charges shall be revised by changing the number in "Item #2 – Flat Rate Sewer Usage" to Item #3 and adding "Item #2 – Metered Sewer-Flow Usage" to state:

"2. <u>Metered Sewer-Flow Usage</u>. All large Non-Domestic Establishments connected to the Sewer System with an average sewer flow of 25,000 GPD or greater, who is not connected to the Authority's Water System, shall pay sewer rates on the basis of their sewer flow at 175 gallons per equivalent dwelling unit (EDU), payable at the rate of \$85.00 per EDU (or at the current billing rate as established by the Authority) with EDU's being rounded off to the nearest whole EDU, with a minimum of 1 EDU per quarter. All Non-Domestic Establishments using this method must voluntarily purchase an Authority approved sewer meter, with all expenses being the responsibility of the Non-Domestic Establishment."

### Adopted April 7, 2016:

Exhibit B of the Penn Township Municipal Authority Sewer Rules and Regulations has been revised. (See Exhibit B – Plumbing Details Lateral Connection, Dated March 7, 2016)

### Adopted November 2, 2017:

Effective January 1, 2018, all PTMA sewer rates will <u>decrease</u> from \$85.00 per Equivalent Dwelling Unit (EDU) per quarter to \$80.00 per EDU per quarter or \$320.00 per annum per EDU.

#### Adopted November 7, 2019:

Effective January 1, 2020, all PTMA sewer rates will <u>increase</u> from \$80.00 per Equivalent Dwelling Unit (EDU) per quarter to \$95.00 per EDU per quarter or \$380.00 per annum per EDU.



# Penn Township Municipal Authority Sewer Rules & Regulation Revisions

## Adopted December 5, 2019:

The following verbiage shall be added to the Penn Township Municipal Authority Sewer Rules and Regulations Section 3.6 – Properties Requiring Grinder Pumps, Part (b) Materials, Installation, and Testing:

(4) No person shall initially operate the grinder pump system unless an authorized Authority representative is on site. The shut off valve shall not be opened or operated until the authorized Authority representative permits it.

#### Adopted November 3, 2022:

Effective January 1, 2023, all PTMA sewer rates will <u>increase</u> from \$95.00 per Equivalent Dwelling Unit (EDU) per quarter to \$105.00 per EDU per quarter or \$420.00 per annum per EDU.
